PROCUREMENT OF MEDICAL INSURANCE COVER, GROUP LIFE, LAST EXPENSE AND WIBA COVER.

1.0 INTRODUCTION:

The County Government of Kitui intends to procure Medical Insurance, Group Life, Last Expense and Wiba Cover for all County Government Officers in fulfillment of its obligations under the Employment Act that requires every employer to make provision for sufficient medical attention to Employees.

2.0 THE OBJECTIVE

The purpose of the Tender is to invite all eligible registered insurance firms licensed by Insurance Regulatory Authority (IRA) to offer Insurance services in Kenya to provide a Medical Insurance, Group Life, Last Expense and Wiba Cover for all County Government Officers in the County Government of Kitui.

3.0 SCOPE

The cover is for all County Officers. The Insurance sought is intended to cover all County officers and shall be on family shared basis covering member, spouse and dependent children less than 18 years of age and up to a maximum of twenty– six (26) years of age if still in school.

The successful Insurance firm shall enter into a **One (1) year** contract **renewable**, the second year's renewal shall depend upon satisfactory performance in the first year.

4.0 THE MEDICAL COVER

The Cover has been designed to provide;

In-patient per family, out-patient per family, maternity per family, dental per family and optical per family benefits on family shared basis.

- (i) In-patient
- (ii) Out-patient
- (iii) Dental cover per family
- (iv) Optical cover per family
- (v) Maternity per female member/married male member
- (vi) Last expense

(vii) WIBA

Interested Insurance firms are invited to submit their bids and are required to present written evidence of the following: -

- (i) Provide Certificate of Registration/or Incorporation
- (ii) Provide a valid tax Compliance Certificate from Kenya Revenue Authority.
- (iii) Provide a valid single business permit
- (iii) Provide a valid copy of underwriting certificate from Insurance Regulatory Authority (IRA)
- (iv) Attach a valid evidence membership from Association of Kenya Insurers (AKI)
- (v) Bidders must not share a link in the IFMIS System during uploading of the documents

The tender documents containing detailed information on the tenders can freely be downloaded from the County Government of Kitui Website (www.kitui.go.ke) or PPIP Portal: www.tenders.go.ke with effect from **24th October, 2024**.

Bids shall be valid for a period of 140 days after bid opening. Tenders must be accompanied by bid security of **Ksh.4,500,000.00 (Four Million and five hundred thousand only)** in form of a bank guarantee.

Tenderers will be required to submit One (1) complete hard copy (original)** which must be dropped at the tender Box situated at the entrance of the Annex administration Block Building, Savani Road opposite the Kitui Central CDF Office on or before the tender closing date and time (**Friday 1st November, 2024 at 12:00 Noon**). **Incase of any inconsistency between the manual (physical) tender document and the one submitted through the IFMIS Portal, the online document (through IFMIS) shall prevail.**
