- ii) Be Registered with National Construction Authority (NCA) and attach copies of the registration Certificate and Practicing License Category NCA 8 and Above
- iii) Properly fill, sign and stamp the Form of Tender which is inclusive of the following: -
 - Confidential Business Questionnaire.
 - Certificate of Independent Tender Determination.
 - Self-Declaration of the Tenderer.

iv) Attach a Current Certified Copy of CR12 Certificate obtained not more than Twelve (12) months from the date of this advert

v) Attach all the directors certified copies of national identity cards.

vi) Valid business permit/licenses

vii) Must serialize/ paginate all pages for each bid submitted

vii Must Submit a copy of a current/valid Tax Compliance Certificate or Exemption certificate from Kenya Revenue Authority.

ix) Tenderers MUST attach signed and stamped site visit certificates. Site visits will be on **Wednesday 30th April, 2025**. Interested bidders should assemble at respective sub-county offices by 10.0 AM.

NOTE:

Further, bids from the following tenderers shall be treated as NON-RESPONSIVE and therefore subject to Automatic disqualification:

1. Bid documents from a tenderer whose Directors/Owners/Shareholders are either Public Servants, State Officers of the County Government of Kitui or their Spouses and or their Children;
2. Bid documents from a tenderer who has been served with a default notice on ongoing projects;
3. Having been debarred by the Public Procurement Regulatory Authority (PPRA)
