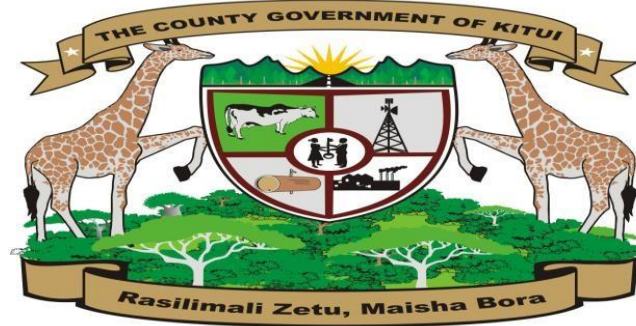

Interested bidders should note that only those meeting the criteria indicated below as minimum, supported by relevant documents at submission will be considered for further evaluation.

MANDATORY REQUIREMENTS

- i) Attach valid copies of the Company Registration/Incorporation Certificate
- ii) Properly fill, sign and stamp the Form of Tender which is inclusive of the following:-
 - Confidential Business Questionnaire.
 - Certificate of Independent Tender Determination.
 - Self-Declaration of the Tenderer.
 - Conflict of Interest
- iii) Attach a Current Certified Copy of CR12 Certificate
- iv) Attach all the directors certified copies of national identity cards.
- v) Valid business permit/licenses
- vi) Must serialize/ paginate all pages for each bid submitted
- vii) Bidders must not share a link in the IFMIS system during the uploading of the bid documents
- viii) Must submit a copy of a current/valid Tax Compliance Certificate or Exemption certificate from Kenya Revenue Authority.
- ix) Attach a copy of Bid bond from a recognized financial institution and submit original hard copy at the head of supply chain office.

NOTE:

Further, bids from the following tenderers shall be treated as NON-RESPONSIVE and therefore subject to Automatic disqualification:

1. Bid documents from a tenderer whose Directors/Owners/Shareholders are either Public Servants, State Officers of the County Government of Kitui or their Spouses and or their Children;
2. Bid documents from a tenderer who has been served with a default notice from ongoing projects;
3. Having been debarred by the Public Procurement Regulatory Authority (PPRA)
