The specification of the required land is as follows: -

- I. Land should be located in Within Migwani Market Area
- II. Easily accessible by traders`
- III. Land parcel should be accessible by road
- III. Land parcel should have no disputes
- IV. Title deed should not have encumbrances (Attach copy of current official search)
- V. Where the land is registered in more than **one name, proof of authority to act from co-owners should be attached.**

- VI. The land should be registered with relevant registration documents
- VII. Land is on stable ground

Bidders are required to comply with section 74(1) (i) of Public Procurement and Asset Disposal Act 2015. That makes it mandatory "requirement for serialization/pagination of bid documents by the bidder" for each bid submitted.

Eligible candidates may download the Tender Documents from the **Kitui County Website (www.kitui.go.ke)** and **Public Procurement Information Portal (PPIP) (www.tenders.go.ke)** with effect from **25th May 2026**. After downloading the tender documents bidders are requested to present their Particulars to the Supply Chain Management Office for registration, physically to the Procurement office at The County Treasury.

Bidders Must submit hardcopy of their bid in plain sealed envelopes with the tender number clearly marked and bearing no indication of the identity of the tenderers and should be addressed to:
