## MANDATORY REQUIREMENTS

Interested bidders should note that only those who meet the criteria indicated below as minimum, supported by the relevant documents at submission will be considered for further evaluation: -

1. Provide copies of Company registration, Business permit/Licence, VAT/ PIN and valid TAX Compliance Certificate;
2. Proof of eligibility as having been registered with the National Treasury for firms belonging to Youth, Women and Persons Living with Disabilities;
3. Bidders are required to comply with section 74(1) (i) of the PPAD Act, 2015 that makes it a mandatory **"requirement of serialisation/pagination of pages by the bidder"** for each bid submitted.
4. The Tender Form and Confidential Business Questionnaire must be fully filled and signed by authorized person(s) with full names of Directors/Owner(s); and copies of company registration Certificate (CR12) or Business Name Registration Certificate and ID Cards of the Director(s)/Owner(s) must be attached.
5. Must submit a dully filled and signed; i) Certificate of independent tender determination ii) Tender eligibility iii) Self-declaration forms (SD1, SD2 and declaration and commitment to the code of ethics

Further, Tenders from the following Tenderers shall be treated as **non-responsive** and therefore subject to disqualification: -

1. A Tender from a Tenderer whose Directors/Owners/shareholders are either public servants, state officers or their spouses and or their children, serving in the County Government of Kitui or The County Assembly of Kitui.
2. A Tender from a Tenderer who has been served with a default notice on previous and on-going Projects.
3. **A Tenderer who makes attempts of any kind to influence the tender outcome by soliciting for information during tender evaluation,**

**communicating with tender evaluators, corrupting any Public Officers and any other forms to win favors shall automatically be disqualified and recommended for prosecution;**
