MANDATORY REQUIREMENTS

Interested bidders should note that only those meeting the criteria indicated below as minimum, supported by the relevant documents at submission will be considered for further evaluation: -

1. Provide copies of Valid Company incorporation/Registration Certificates;
2. Must submit a copy of a current/valid Tax Compliance Certificate or Exemption certificate from Kenya Revenue Authority.
3. Provide Copies of Valid Business Permit Certificate/Licenses.
4. The Tender Form and Confidential Business Questionnaire must be fully filled and signed by authorized person(s) with full names of Directors/Owner(s), with copies of their National Identity Cards and copies of Business Registration Certificates.
5. Bidders for Provision of General Cleaning Services **Must** Visit the Hospital to access the Scope of the Service to be offered & Sign declaration of the site visit form on **29th of July 2026** During Normal Working Hours-8am to 5pm.
6. Properly fill, sign and stamp the Form of Tender which is inclusive of the following:-
 - Confidential Business Questionnaire.
 - Certificate of Independent Tender Determination.
 - Self-Declaration of the Tenderer.
 - Conflict of Interest
7. Attach a Current Certified Copy of CR12 Certificate
8. Attach all the directors certified copies of national identity cards.
9. Must serialize/ paginate all pages for each bid submitted
10. Bidders for Provision of medical and general hospital waste disposal management services for Kitui County referral hospital and Mwingi Level 1v Hospital Must Visit the Sites on 29th of July 2026 During Normal Working Hours-8am to 5pm.
10. Bidders MUST Provide for Zero Point Zero three percent (0.03%) Capacity building Levy order 2023 as Per PPRA Circular No. 01/2024 of 30th August 2024 of the Total Amount Quoted.

Further, Tenders from the following Tenderers shall be treated as **non-responsive** and therefore subject to disqualification: -

- (i) A Tender From a Tenderer whose Directors/Owners/shareholders are either public servants, state officers or their spouses and or their children, serving in the County Government of Kitui.
- (ii) A Tender from a Tenderer who has been served with a default notice on previous and on-going Projects.
- (iii) Having been debarred by the Public Procurement Regulatory Authority (PPRA)
- (iv) **A Tenderer who makes attempts of any kind to influence the tender outcome by soliciting for information during tender evaluation, communicating with tender evaluators, corrupting any Public Officers and any other forms to win favors shall automatically be disqualified and recommended for prosecution;**
